Dear Kristin:

I am fully aware that I can NOT, nor do I have any right to re-assign the Gliderport lease to anyone including Mr. Robin Marien. You are aware that I left the Gliderport on January 1, 2009 and sold the Air California Adventure Inc. to Mr. Marien. This basically included the equipment and gliders on the property. Mr. Marien fully understands that he does not have a lease or even a hold-over lease at the moment. The lease was never a part of the Air California Adventure, Inc. transaction. We have not sublet the property, nor have we asked for any form of rent payment for the property or buildings. I explained to you and Mr. Sandoval he was the most capable person to carry on with the operation and he was willing to work with the City bringing the property up to code. We both realize that if under the circumstances very few individuals with his knowledge and qualifications would have been willing to step into the situation without some guarantees. I would like to point out that I gave more than one full month's notice to the City before Mr. Marien assumed any day-to-day management role at the Gliderport and would very much like to work in good faith with the City and Mr. Marien to resolve this issue to the benefit of all parties involved.
